Additional Terms Used in this Document

Consent to and Use of Recordings

provided in this Release. Client and any Client Licensees are not obligated to exercise any of the rights granted under this Release.

Representations and Warranties

Parent acknowledges that, as the parent or guardian of the Minor, both Parent and Minor will be bound by the terms of this Release. Parent represents and warrants that Parent's grants and agreements in this Release do not and will not conflict with any agreements with, or violate any rights of, any third party.

Waiver of Legal Claims

Parent waives and releases Client, Client Licensees, and their respective directors, officers, employees, funders, agents, and assigns (collectively, "Beneficiaries"), from any legal claims, including, without limitation, any claims relating to copyright, rights of publicity or privacy, defamation, false light, infliction of emotional distress, or moral rights that Parent or Minor may have with respect to Client's or any Client Licensee's use of the Recordings. Parent's sole remedy for any breach of this Release by Client or any Client Licensee will be limited to damages. Parent or Minor may not rescind this Release or seek any injunctive or other equitable relief.

Entire Agreement; Amendment
